The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Criminal Sexual Conduct - 1st Degree - Penetration or Contact under 14 - Actor > 36m older**

Minnesota Statute: 609.342.1a(e), with reference to: 609.342.2(b), 609.342.2(a), 609.3455.10, 609.342.2(c)

Maximum Sentence: 30 YEARS AND/OR \$12,000-\$40,000, PLUS 10 YEARS CONDITIONAL RELEASE

Offense Level: Felony

Offense Date (on or about): 09/01/2025

Control #(ICR#): 25009840

Charge Description: That on or about 9/1/2025, in Hennepin County, Minnesota, JOSE RAMON TRACONIS SALVADOR, born 08/31/1980, engaged in sexual penetration with victim, a person under fourteen (14) years of age at the time of the act, and more than thirty-six months younger than JOSE RAMON TRACONIS SALVADOR.

**COUNT II**

**Charge: Criminal Sexual Conduct-1st Degree-Penetration under 16/ Significant rel-Multiple acts**

Charge Description: That on or about 9/1/2025, in Hennepin County, Minnesota, JOSE RAMON TRACONIS SALVADOR, born 08/31/1980, engaged in sexual penetration with victim, a person under

sixteen (16) years of age at the time of the sexual penetration, and JOSE RAMON TRACONIS SALVADOR is the victim's mother's significant other, and the sexual abuse involved multiple acts committed over an extended period of time.

## STATEMENT OF PROBABLE CAUSE

1-26-2026 - THIS COMPLAINT HAS BEEN AMENDED TO ADD COUNT 2 WHICH CHANGES THE CHARGING SUBDIVISION UNDER 609.342 FROM SUBD. 1a(e) to SUBD. 1a(h)(iii) IN LIGHT OF THE COURT OF APPEALS OPINION IN STATE V. ORTEGA-HERRERA (A24-1321) ISSUED DECEMBER 1, 2025. THERE ARE NO CHANGES TO THE PROBABLE CAUSE LANGUAGE.

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On October 25, 2025, law enforcement officers were dispatched to the Hennepin County Medical Center on a report of a sexual assault of a minor. The juvenile victim, identified herein by fictitious initials ABC, reported she was sexually assaulted by her stepfather, JOSE RAMON TRACONIS SALVADOR (DOB 08/31/1980). ABC is 13 years old. The sexual abuse happened at TRACONIS SALVADOR and ABC's home in Bloomington, Hennepin County, Minnesota.

ABC reported that on October 22, 2025, she was doing homework in the living room when TRACONIS SALVADOR called her into his bedroom where he was giving her younger brother a bath. When she got into the room, she saw TRACONIS SALVADOR standing by the foot of the bed. TRACONIS SALVADOR reached out to hug her, and she tried to pull away, but TRACONIS SALVADOR would not let her go. TRACONIS SALVADOR then threw her on the foot of the bed and began to take off her clothes. ABC tried to resist but she was unsuccessful. TRACONIS SALVADOR removed all of her clothes and then rubbed his erect penis on her vagina as she laid on the bed with her legs spread. TRACONIS SALVADOR then inserted his penis into her vagina and began thrusting it back and forth. ABC attempted to get up and TRACONIS SALVADOR pushed her back down. TRACONIS SALVADOR then ejaculated on the carpet. TRACONIS SALVADOR proceeded to clean ABC up.

ABC reported this wasn't the first time this has happened, and it has happened approximately eleven times since September of this year.

In the medical exam of ABC, ABC sustained a posterior fourchette tear which is consistent with sexual assault.

A search warrant was obtained and executed on TRACONIS SALVADOR'S residence. Suspected seminal fluid was observed on the carpet near the foot of the bed. It was preliminarily tested for seminal fluids and tested presumptively positive.

TRACONIS SALVADOR was located at a residence in Eagan and placed under arrest. He agreed to provide a Mirandized statement. TRACONIS SALVADOR denied sexually assaulting ABC.

TRACONIS SALVADOR is 382 months older than ABC.

TRACONIS SALVADOR is currently in custody in the Hennepin County Jail.

**SIGNATURES AND APPROVALS**

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
