### Commit to Commissioner of Corrections

Commit to Commissioner of Corrections at the MN Correctional Facility - St. Cloud for 172 months.

Credit for time served amount is 152 days.

Conditional release after confinement has been set at 10 years.

*This sentence consists of a minimum term of imprisonment equal to two-thirds of the total executed sentence, and a maximum supervised release term equal to one-third of the total executed sentence, unless the sentence is life or life without the possibility of release.*

Time to Serve: 172 months

### Conditions

Ordered on March 27, 2026:

Defendant must comply with the following conditions:

- Predatory offender registration required if you are homeless, you must check-in on a weekly basis at a local police station
- Supply DNA sample
- Do not ship/transport/possess or receive firearm or ammo


