

Below is a table summarizing X users' complaints about Abra, focusing on difficulties withdrawing or accessing funds, particularly from Abra Boost, based on posts from January 1, 2025, to July 29, 2025. The complaints highlight themes of frozen accounts, disabled withdrawals, poor support communication, and suspicions of insolvency, with activity concentrated in July 2025.

- **Concentration in July:** Complaints surged in mid-to-late July 2025, aligning with reports of Abra pausing withdrawals for international customers, citing "external circumstances" and "risk management efforts" (,). [cryptonews.com](#) [dlnews.com](#)
- **Common Themes:** Users consistently report frozen accounts, especially in Abra Boost, disabled withdrawals (both to external wallets and intra-app transfers), and lack of communication from Abra's support and CEO Bill Barhydt. Suspicions of insolvency are fueled by Abra's history of regulatory issues and settlements (,). [cryptonews.com](#) [coindesk.com](#)
- **Non-US Focus:** Many complaints, particularly from users like @TonyUponly, highlight issues affecting non-US customers, with no clear explanation for the geographic restriction (,). [cryptonews.com](#) [dlnews.com](#)
- **User Frustration:** Repeated posts from users like @ValentinaP\_NY and @OscarMartn2564 show escalating frustration, with direct appeals to the CEO and accusations of scams or mismanagement.
- **Recovery Pitches:** Several threads include replies from accounts like @PauloBetowalder and @KBphase\_ promoting recovery services (e.g., @Beacon\_links), indicating a pattern of users seeking external help (,,).
- **Contextual Background:** Abra's prior regulatory troubles, including a \$82.1 million settlement with 25 US states in 2024 for operating without licenses and allegations of insolvency by Texas regulators in 2023, add weight to user concerns about the platform's stability (,,).
