

☐ Before leaving the courthouse today, you must go to the Office of the Clerk of Court, located on the 4th Floor, 220 S. Main Street, Gainesville, FL to arrange for payment. Payment plans are available if you cannot pay the full amount today. A payment plan incurs a one-time service charge of \$25.00, s. 28.246(4), Fla. Stat. If you fail to make arrangements today, the Clerk will send you a standard payment plan, and you will be responsible for making the payments. If you fail to make those payments, the Clerk will refer the matter for collections, which will result in the imposition of additional monetary sanctions including \$10 to record the civil judgment and suspension of your driver's license. If you absolutely cannot pay, you may petition the court to convert some of this total to community service hours. Failure to complete community service hours by the court-imposed deadline will cause the financial obligation to be reinstated.




