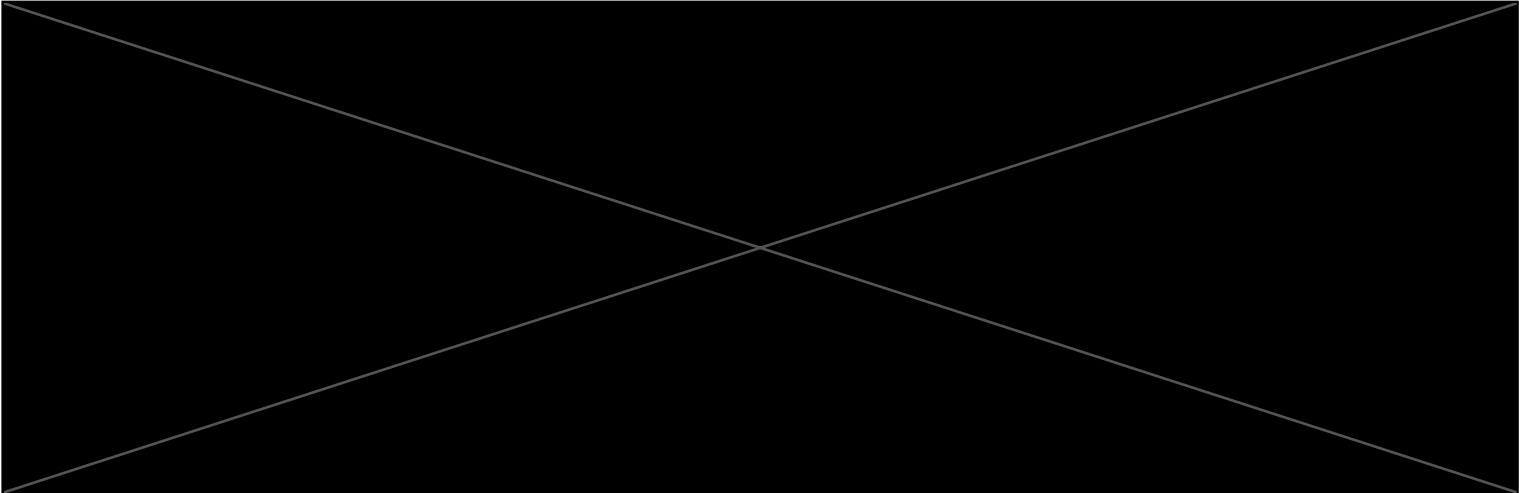

ON 10/17/2025, I SPOKE WITH THE REPORTEE/VICTIM, [REDACTED], VIA PHONE WHO WAS REPORTING A THEFT THAT OCCURRED ON 10/14/2025.

THE VICTIM ADVISED OR CONFIRMED THE FOLLOWING:

ON 10/14/2025, BETWEEN APPROXIMATELY 1700 HOURS AND 1730 HOURS SHE WAS EATING AT "PAIGES ROOT-BEER STAND" LOCATED AT 20430 EAST PENNSYLVANIA AVENUE IN MARION COUNTY FLORIDA. THE SUSPECT, DARIAN GONZALEZ MALDONADO, CALLED HER AND WAS ASKING ABOUT A VEHICLE; HOWEVER, THE VICTIM COULD NOT UNDERSTAND HIM WELL AND ADVISED HIM TO JUST COME BY AND JOIN HER AT THE RESTAURANT.

THE VICTIM PREVIOUSLY EMPLOYED THE SUSPECT TO HELP HER PERFORM HANDYMAN SERVICES APPROXIMATELY BETWEEN MAY 2025 AND AUGUST 2025.

THE SUSPECT ARRIVED AT THE RESTAURANT AND ASKED THE VICTIM IF HE COULD USE HER JUMPER CABLES. THE VICTIM WENT TO THE REAR OF HER 2015 BLACK FORD PICKUP TRUCK BEARING FLORIDA TAG: 15EUEQ AND WAS RETRIEVING THE JUMPER CABLES. THE VEHICLE WAS PARKED AT THE NORTH WEST PORTION OF THE PARKING LOT.

DURING THIS TIME, THE SUSPECT ASKED THE VICTIM IF HE COULD HAVE A CIGARETTE TO WHICH THE VICTIM TOLD HIM "YOU KNOW WHERE THEY'RE AT" WHICH SHE CONFIRMED WAS HER INDICATING TO THE SUSPECT TO ENTER HER LISTED VEHICLE TO RETRIEVE A CIGARETTE.

DURING THIS TIME, THE VICTIM'S MOTHER IN LAW, [REDACTED] AND THE VICTIM'S 12 YEAR OLD SON, [REDACTED] WERE STANDING IN THE AREA OF THE REAR PASSENGER SIDE OF THE LISTED VEHICLE.

THE VICTIM BELIEVES SHE MAY HAVE LEFT THE FRONT DRIVER SIDE DOOR OPEN TO THE LISTED TRUCK AT THIS TIME. THE SUSPECT THEN ENTERED THROUGH THE FRONT DRIVER SIDE DOORWAY AND WENT INTO THE LISTED VEHICLE FOR APPROXIMATELY 10 SECONDS.

WHEN THE SUSPECT EXITED, HE APPROACHED THE VICTIM AND SHE GAVE HIM THE JUMPER CABLES. THE SUSPECT THEN HUGGED THE VICTIM AND SAID HE NEEDED TO BORROW HER "PIECE" AS HE WAS HUGGING HER. THE SUSPECT ALSO SAID "JUST IN-CASE THIS NIGGA PULLS SOMETHING OUT ON ME".

THE VICTIM KEPT A BLACK RUGER .38 SPECIAL REVOLVER INSIDE THE CENTER CONSOLE OF THE LISTED VEHICLE WHICH SHE BELIEVED THE SUSPECT WAS REFERRING TO AND WAS TAKEN FROM THE VEHICLE.

THE VICTIM WAS TELLING THE SUSPECT HE CAN NOT, WHICH SHE ADVISED WAS HER REFERRING TO THE SUSPECT NOT TAKING THE FIREARM.

THE SUSPECT SAID "IT'LL BE ALRIGHT I'LL BE RIGHT BACK". THE SUSPECT LET GO OF THE VICTIM AND WALKED TO A SILVER JEEP CHEROKEE WITH A BUSTED OUT WINDSHIELD. THERE WAS AN UNKNOWN HEAVY SET WHITE FEMALE WITH DARK HAIR WITHIN THE JEEP. THE JEEP THEN DROVE OUT OF THE PARKING LOT AND WEST BOND ON EAST PENNSYLVANIA AVENUE.

THE VICTIM DROVE HOME AND DID NOT INITIALLY REPORT THIS INCIDENT. APPROXIMATELY 15 MINUTES LATER, THE VICTIM CALLED THE SUSPECT VIA PHONE, BUT HE DID NOT ANSWER. THE SUSPECT THEN CALLED THE VICTIM BACK, DURING WHICH TIME THE VICTIM SAID "GIVE ME MY SHIT NOW", BUT THE SUSPECT KEPT SAYING THE SAME THING HE WAS SAYING BEFORE REGARDING THE FIREARM.

THE VICTIM ADVISED SHE DID NOT REPORT THIS INITIALLY BECAUSE SHE WAS WANTING THE SUSPECT TO GIVE THE FIREARM BACK IN LIEU OF HAVING HIM ARRESTED. THE VICTIM

THE VICTIM ADVISED THE STOLEN FIREARM IS IN FACT A TAURUS .38 SPECIAL. THE VICTIM ADVISED THE REMAINDER OF THE FIREARM DESCRIPTION IS THE SAME.

THE VICTIM ADVISED SHE BELIEVES THE SUSPECT IN THIS CASE, DARIAN GONZALEZ MALDONADO, MAY HAVE ALREADY LEFT THE STATE AND IS POSSIBLY TRAVELING TO CALIFORNIA. THE VICTIM BELIEVES THE SUSPECT MAY BE TRAVELING WITH A FEMALE SUBJECT, POSSIBLY IDENTIFIED AS DIANA GIULLEN.
