away from the home invader along with two other "rusted" guns he had in and around his home and wrapped them in a black t-shirt. The DEF stated he hid the guns wrapped in the black t-shirt in an overgrown area on the other side of his chain-link fence because he knew he could not possess a firearm as a convicted felon.
Detectives observed the butt end of a semi-automatic handgun sticking out from under the black t-shirt. Further investigation revealed the 3 firearms wrapped in the t-shirt.
DEF is a convicted felon. Citrus County Case # 092003CF000189XXXAXX.
DEF is currently on federal supervised release.
