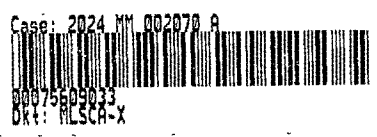

in the background and then the line disconnected. The VIC advised the DEF was telling the unknown male to ask the VIC where his belongings were. The VIC stated she also heard the DEF saying that he was at her old address in Jacksonville ( [REDACTED] ). The VIC said the DEF's parents knew where the DEF's belongings were and there was no reason for the DEF to contact her.  
The VIC stated she started panicking because she has a long history of domestic violence in Jacksonville with the DEF and she was afraid he found out her new location. The VIC has suffered a substantial amount of stress, and anxiety due to the DEF breaking his no contact order.  
The no contact order was verified via Teletype by ID #1331A. Teletype operator 1331A told me the no contact order is non-expiring. I contacted Teletype again and Teletype operator #1209 confirmed that the number that called the VIC is not connected to any LEO.  
The VIC provided me with a picture of the DEF's GA ID. The VIC positively identified the DEF by his GA ID.
