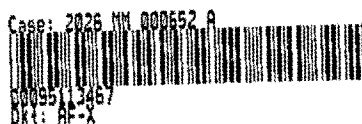

On 3/29/26, ASO Deputies responded to [REDACTED] in reference to a domestic battery. Once on scene, I first observed the DEFENDANT ( H. Velasquez, dob: 12/22/88 ) pacing in front of the listed address. When I approached her, she was visibly emotionally upset and I could detect the odor of an alcoholic beverage on her breath. She was crying and was having a hard time explaining to me what was going on.

The apartment door opened and I next made contact WITNESS and the VICTIM [REDACTED]. The WITNESS and VICTIM used to be married and have three children together, who were present during the altercation.

I spoke to the WITNESS separately, and she stated that the DEFENDANT and VICTIM are in a intimate dating relationship (for the past 8 months), and got into a heated argument at their residence early this morning. The VICTIM decided to take his children back to their mother to defuse the situation, but the DEFENDANT followed him to the WITNESS'S location.

As the VICTIM was walking into the residence, the WITNESS observed the DEFENDANT strike the VICTIM several times with a closed fist in his face. The VICTIM'S shirt was torn and had bruising consistent with being battered. The WITNESS was also struck with a glancing blow across her right temple as the DEFENDANT struck the VICTIM.

Deputy Minaya interviewed the VICTIM separately, and the VICTIM eventually admitted that the DEFENDANT struck him several times with a closed fist.

I watched the Ring Door Camera footage, which captured some of the incident. The DEFENDANT stated that she would "fuck up" the VICTIM and also stated that would "shoot" him.

Post Miranda, the DEFENDANT refused to answer any questions regarding the incident.
